

## Terms and Conditions

This is an important document which limits the rights of the travel participant. Please read and consider it carefully.

---

In these terms and conditions a reference to:

- a) "Tour" means the package named as 'A Parisian Experience' as set out in the booking confirmation stating when the package starts and ends, the accommodation, guided shopping, and other inclusions.
- b) "Client" means the person(s) named in the particulars of the booking confirmation.
- c) "Full Price" means the package price per person option as advertised. The Full Price varies depending on room standard and whether single or twin share basis.
- d) "Start Date" for the Tour is 3pm on Monday 20th May, 2019 at the Hotel Bel Ami, Paris.

### Insurance

It is a condition of the Tour that you are fully insured. Evidence of comprehensive Travel Insurance is a mandatory condition of booking. In Clients own interests, you are strongly recommended to effect travel insurance through a reputable company. The policy should reflect personal accident and sickness, accidental loss of baggage and money, payment and cancellation fees and curtailment expenses.

### Deposits

Once availability has been confirmed, a deposit of AUD\$750 will reserve your place for the limited place Tour. A payment of deposit indicates an acceptance of all the terms and conditions by the Client.

## **Cancellation Policy**

There are no cancellation fees 100 days prior to the Start Date of the Tour. If you cancel within 100 - 60 days of the Start Date there will be a fee of \$750 (the required deposit amount) imposed to cover handling fees and the hotel's cancellation policy penalty. Less than 60 days before the Start Date, no refund will be available.

Note - the Full Price is due 100 days prior to Start Date of the Tour.

## **Refunds**

No refund will be issued to those failing to join the Tour, or for the package accommodation or any other services not utilised, or for a partially completed Tour for any reason.

## **Travel Documents**

All Clients require valid passports with at least six months validity remaining. Clients are also responsible for necessary visa and health certificates, and must meet all costs incurred to comply with such requirements.

## **Airport Departure Taxes**

Departure taxes, where levied, are the direct responsibility of the client.

## **Excess Luggage**

Clients will be responsible for any excess luggage allowances that might be imposed by domestic or international airlines in countries which the Client is travelling.

## **Itinerary**

We reserve the right to vary or cancel the itinerary, accommodation, or services nominated in the Tour descriptions should circumstances warrant that such changes would be in the best interest of the Client, or for any other operational reason.

The commencement of the Tour is subject to sufficient numbers booking the Tour, and the right is reserved to cancel the Tour, should there not be sufficient bookings, in which case deposits will be refunded. However, Client's travel or other expenses already incurred cannot be reimbursed.
